Park & Field Use Waiver and Indemnification

1. As used herein, the term "Field" shall include the South Fifth Avenue Park; the David Whalen Community Park; Russell Park; their parking lots, buildings, fields, playgrounds, tennis courts, and any and all other fixtures and appurtenances thereto.
2. The person(s) and/or organization(s) entering into and signing this agreement shall be held jointly and severally liable for the requested Fields. They shall be responsible for any and all costs for repairs and damages that arise out of the improper or negligent use of the Fields.
3. The Village of Ilion shall not be responsible for any accidents, injuries or the theft of personal property by authorized or unauthorized users of the designated Field.

5. Use of the Fields shall be limited to the dates, times and uses as approved by the Village of Ilion.
6. In consideration of the Village of Ilion permitting the use of these Fields while participating in any activities sponsored either by the Village or any other group or individual, realizing that there is some danger in these sporting activities, I do hereby consent, agree and bind myself, my heirs, administrators and executors, to indemnify and save harmless the Village of Ilion, its officers, agents, servants and employees against all loss, actions, causes of action, claims, demands, damages, costs, attorneys fees, loss of services, expenses and compensation, on account of or in any way growing out of, any personal injuries or property damage which may occur.

## Rules & Regulations for Use of Fields

1. As used herein, the term "Field" shall include the South Fifth Avenue Park; the David Whalen Community Park; Russell Park; their parking lots, buildings, fields, playgrounds, tennis courts, and any and all other fixtures and appurtenances thereto.
2. Written request for usage of any of the Fields shall be made to the Village of Ilion ("Village") through the Village Municipal Office for approval. Said written request shall be on the form provided. At least one of the adults listed as responsible must be at the Field at all times.
3. Selling, raffling or donating any alcoholic beverages is prohibited at the Fields. Consumption of any alcoholic beverages inside the gate of the fields is prohibited. *The sponsoring group and the Responsible Party shall enforce this rule and failure to do so may result in the termination of the use of the Field.*
4. While school and youth events/games are being played and using the Field there will be no smoking allowed at the Fields.
5. The Village may investigate any altercations and/or actions that occur at the Field that it may deem inappropriate.
6. In the event of inclement weather, the caretaker, in consultation with the organization and/or the Responsible Party, shall determine whether the Fields are useable. However, the caretaker shall have sole and final discretion and his or her decision shall be final.
7. **Any usage by individuals under the age of 18 requires the presence of adequate adult supervision at all times.**
8. Profanity, objectionable language and disorderly acts or illegal activities of any kind are absolutely prohibited.
9. The Village has the right to ban, suspend or reprimand any individual, team or league from participating at a Village facility.
10. Any usage fee shall be paid in full before using the Field. NO EXCEPTIONS WILL BE MADE.
11. The Field shall be cleaned by the organization and/or the Responsible Party at the conclusion of the use of the Field. All personal equipment must be removed by 9 AM the next day. If the Village must clean the Field the organization and/or Responsible Party will be charged and billed for such cleanup at a rate of \$45 per hour. Any personal equipment left at the Field past 9AM the following day shall be deemed abandoned and shall be disposed of by the Village.
12. Care must be given to keep the Fields in their present condition. Sweeping puddles is prohibited. Field repairs done by the Village as a result of inappropriate use will be billed to the organization and/or Responsible Party at a rate of \$45 per hour.

13. Unless special written permission has been issued by the Village of Ilion, use of the Field will conclude at 11 PM

14. Fees will be charged to sponsoring organizations as follows for the use of fields at the Dave Whalen Community Park only:

Single Day use per field <u>without</u> lighting	\$ 60.00	Non-refundable
Single Day use per field <u>with</u> lighting	\$ 75.00	Non-refundable
Concession Stand use fee per use	\$ 35.00	Non-refundable
Concession Use for entire Men`s League Season	\$500.00	Non-refundable

**TOURNAMENT FEES:** Paid up front, non-refundable- reschedule date if inclement weather

Friday/Sat/Sun Tournament field use fee	\$180.00	Non-refundable
Friday/Sat/Sun Concession Stand fee	\$ 85.00	Non-refundable
Sat/Sun Tournament field use fee	\$105.00	Non-refundable
Sat/Sun Concession Stand use fee	\$ 50.00	Non-refundable

15. A deposit of \$10 will be charged for any key loaned to the sponsor refundable upon return.

16. Proof of Insurance must accompany all Reservation Form (s) for use.

17. Parking is prohibited on the grass and in all areas other than parking lots at all times, unless the Village issues prior written approval.

18. If you have been approved to use the Field and arrive at the Field to find someone else there, please contact either the caretaker Pat Whalen at 868-5578 or the Village of Ilion Police Department at 894-9911. Be sure to have your paperwork showing approval for use of the Fields with you.

19. No dogs are allowed on the fields except on a leash. All dog waste shall be scooped by the dogs` owners.

It is not the intent of this permit/form and/or deposit to restrict the use of the Fields, but rather for to prevent scheduling conflicts and to assure the Field conditions stay in a safe and usable manner for all.

I have read the regulations and agree to abide by them. I understand that violations of any of the regulations may result in the cancellation of the event at any point and forfeiture of any deposits.
